LOCAL LAW NO. 1 FOR THE YEAR 1995

Section 1.

Title:

A Local Law establishing a date for the meetings of the board of assessment review for the Town of Halcott.

Section 2.

Purpose:

To establish a date for the meetings of the board of assessment review other than that provided in subdivision one of Section 512 of the Real Property Tax Law.

Section 3.

Text:

Pursuant to Section 512(1-a) of the Real Property Tax Law of the State of New York, beginning on the day after the fourth Tuesday of May and so many days thereafter as the board of assessment review deems necessary, such board shall meet to hear complaints in relation to assessments.

Section 4.

Effective Date:

This law shall take effect immediately.
